- iii. Extensions or modifications to this MoU may be made by mutual agreement between SkillifyMe and PIET to align with their evolving goals and requirements.

7. CONFIDENTIALITY OBLIGATIONS

- Both PIET and SkillifyMe agree to maintain strict confidentiality regarding all information and data exchanged or generated under this agreement. This confidentiality obligation extends throughout the term of the agreement and beyond, except as permitted by the terms of this agreement.
- ii. Both PIET and SkillifyMe commit to taking reasonable precautions to prevent the unauthorized disclosure or use of each other's sensitive information. They agree to exercise the same level of care in protecting confidential information as they would for their own sensitive data.
